

TERMS AND CONDITIONS

RESERVATION PROCEDURES: We must receive your completed application and payment in full to fully secure your space. There will be NO GUARANTEED reservation without payment. Upon acceptance of your application, a confirmation will be e-mailed to you. A \$30 fee will apply to all returned checks.

BOOTH SHARING: Exhibitors are not permitted to sublet or share booth space.

FIRE AND SAFETY REGULATIONS: Exhibitors must adhere to all city and state fire regulations.

FLOOR PLANS: Y&M Productions reserves the right to add, delete, or move booth space when necessary.

PORNOGRAPHY: No pornography of any type may be displayed or sold.

LIABILITY INSURANCE: Exhibitors will be required to assume all responsibility for liability insurance.

SMOKING: Big Sandy Superstore Arena is a non-smoking building. All smoking must be done outside in the front of the building.

PETS: All pets must be kept in a cage or on a leash. No dangerous breeds allowed in the show. Dangerous breeds will be determined by the City of Huntington pet ordinances.

INDOOR FLOORS AND WALLS MAINTENANCE POLICY: No floor coverings may be sealed or drilled to the floor or wall in such a manner as to injure or deface any flooring surface; whether indoor or outdoor. Additionally, no booth setup materials are permitted that could result in a hazard to public safety. Each exhibitor is responsible for the final condition of the floor/wall in its exhibit area; including but not limited to, the total and complete repair of all grounds surrounding and within the exhibitor's assigned booth space.

LIABILITY: Exhibitor agrees to observe and comply with all applicable laws, statutes ordinances, rules and regulations. Exhibitor assumes all costs and liability from the use of patented, trademarked, copyrighted or creative rights. Exhibitor agrees to waive and forego all claims for damages and recourse of any kind. Applicant agrees to assume all risks arising out of or relating to its attendance or participation at Tri-State Power & Ink Expo and to protect, defend, indemnify and hold harmless Y&M Productions, the Big Sandy Superstore Arena & Convention Center Huntington, WV, and each of its agents, servants, contractors and employees from any, and all liability, loss, damage or expense it may cause or sustain from any cause whatsoever, including fire, theft, personal injury or property loss.

SECURITY: Tri-State Power & Ink Expo will provide 24-hour security starting at close of move-in on November 10th, 2017 to end of move-out on November 12th, 2017. We suggest you cover all merchandise at the close of show each day. Y&M productions will not be responsible for any theft during or after the show. All booths must be staffed during the entire show.

EARLY TEAR DOWN: Early tear down is strictly prohibited, unless approved by show management.
